PUBLIC NOTIFICATION / O R D E R

This is a notification to all public of Jorhat city, under the jurisdiction of Jorhat Municipal Board, Jorhat that as per relevant sections of the Assam Municipal Act 1956, SWM Rules 2016, PWM Rules 2016 & Plastic Waste Management (PWM) Amendment Rules, 2021 issued by the Govt. of Assam and the Bye-laws framed by Jorhat Municipal Board that any kind of solid waste/household wastages dumped into the drains, roads/public places etc. is strictly prohibited.


If any person/shop/firm/hotels etc. violates the above rules and found seeing disposing their household/shops/Commercial establishments/Hotels etc. garbage in drains, Roads/Public places etc. a fine ranging from **Rs.500 to Rs.3000/-** per day will be imposed at the spot itself & other action as felt appropriate. All Commercial/business establishments, Hotels, Offices, Shops, Institutions, etc. are to **mandatorily** keep the garbage in **Dustbins** so that solid/plastic waste is not dumped in drains, openly on roads, public places, residential areas, commercial areas, etc. & also ensuring that no damage is caused to the environment, like littering/burning of plastics on the roads.

Fine upto Rs.300/- will be imposed for littering/burning of garbage & plastic waste on roads/streets. The Govt. has prohibited the use of 'Single-Use Plastics' (below 75 micron). Any shopkeeper/person found using/selling banned SUP items will have to pay a fine amounting from Rs.500 to Rs.5000/- under the territorial jurisdiction of municipal board, Jorhat.


Moreover, it is to be noted that, door to door waste collection of households (kitchen-wise), business establishments, Hotels, Office, Shops, Institutions, hostels, etc. is being done by the authorized parties i.e.(NGO/SHG) under Jorhat Municipal Board and it is **mandatory** for all residential households, commercial establishments/Hotels, Office, Shops, Institutions, hostels etc. to pay the notified user fees as fixed by Jorhat Municipal Board.

In the task force in addition to Chairperson, Vice-Chairman & Executive Officer, Jorhat Municipal Board, the following Officers/Officials have been authorized and detailed for strict enforcement and imposition of fine/penalty under SWM Rules 2016, PWM Rules 2016 & Plastic Waste Management (PWM) Amendment Rules, 2021 issued by the Govt. of Assam:-


